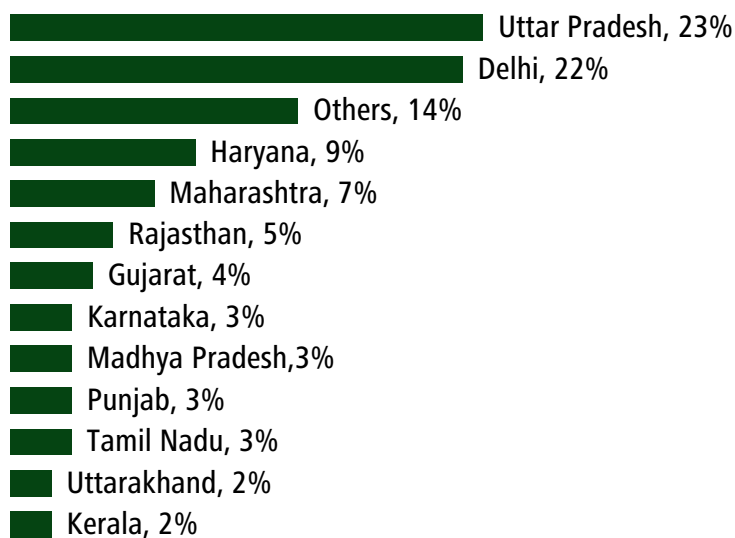

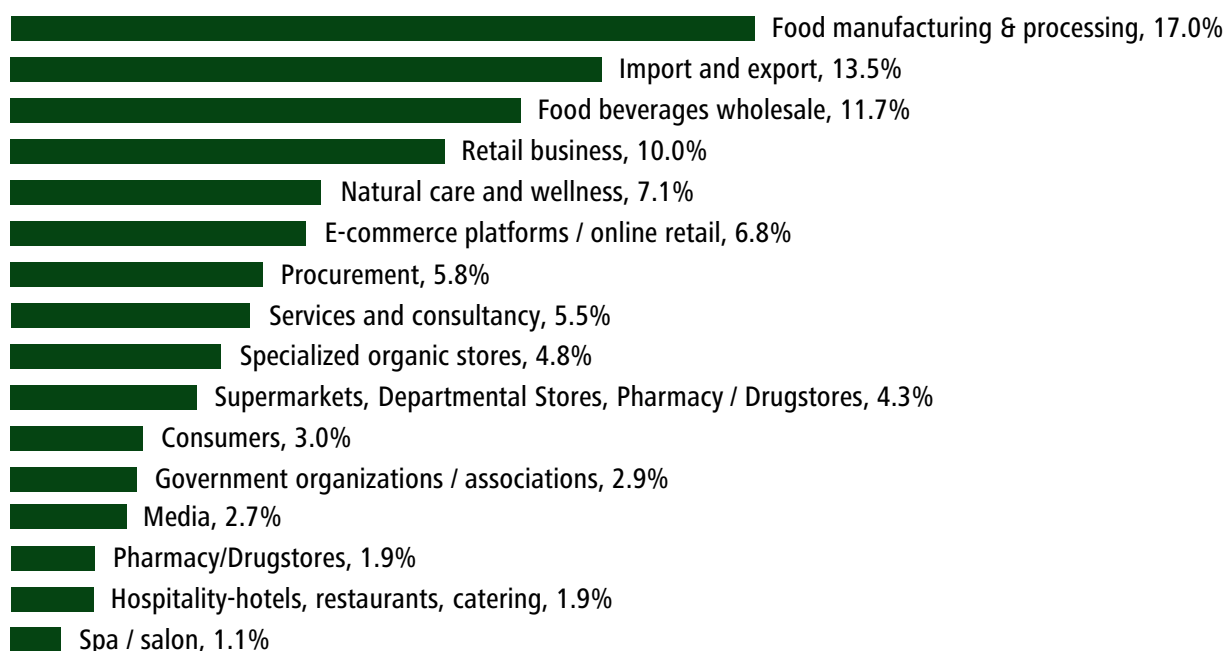

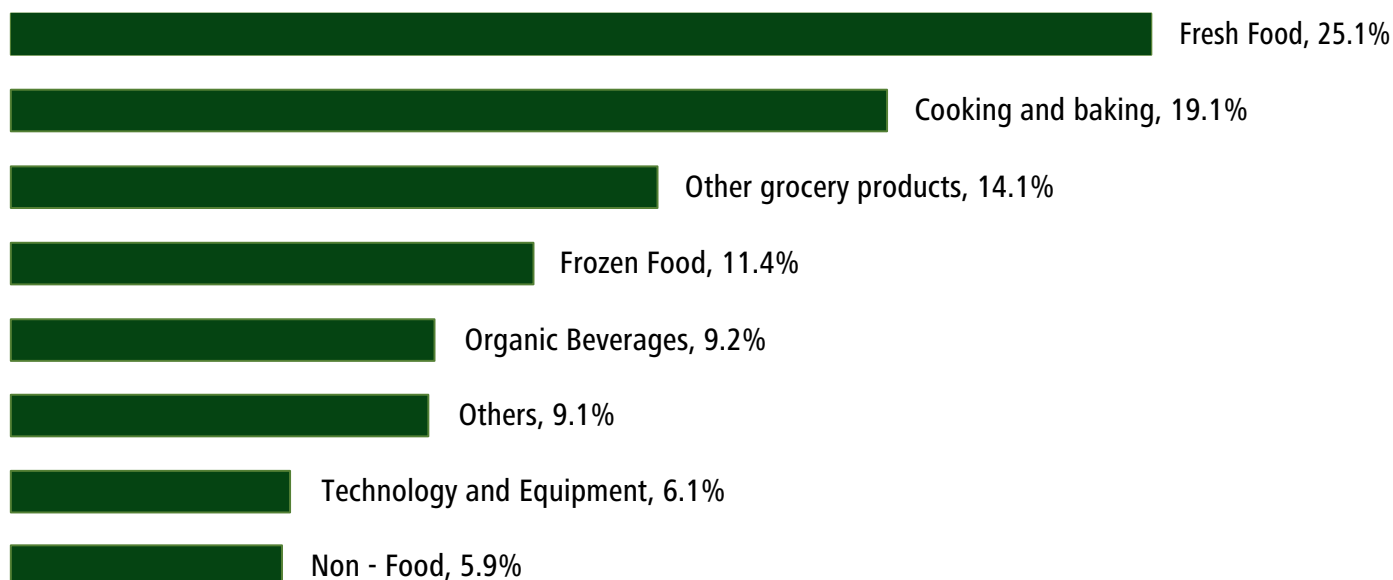
REGIONAL PROVINANCE OF VISITORS



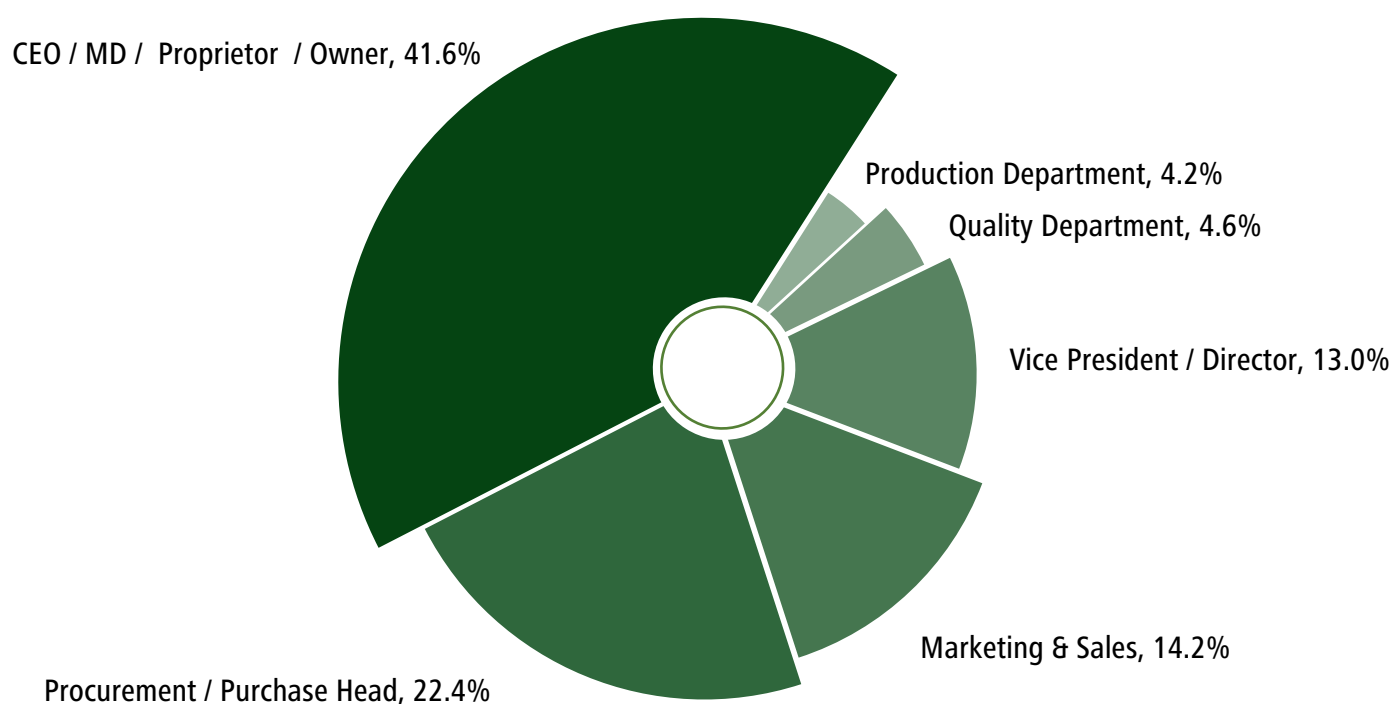
PRODUCT GROUPS
